## *Policy Statement*

The Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act, codified at 20 USC 1092 (f) as a part of the Higher Education Act of 1965, is a federal law that requires colleges and universities to disclose certain timely and annual information about campus crime and security policies. All public and private institutions of postsecondary education participating in federal student aid programs are subject to the compliance act. Violators can be "fined" up to \$35,000 by the U.S. Department of Education, the agency charged with enforcement of the Act and where complaints of alleged violations should be made, or face other enforcement action. Accordingly, the Public Safety Department prepares this report in cooperation with the local law enforcement agencies surrounding our main campus and other campuses of PCCC. The report also includes campus crime, arrest and referral statistics as applicable from campus officials, such as the Dean of Students. Each year, e-mail notification is made to all enrolled students as well as faculty and staff regarding the web site location of the report.

On March 7, 2013, President Obama signed a bill that strengthened and reauthorized the Violence Against Women Act (VAWA). Included within the Act were amendments to the Clery Act that afford additional rights to campus victims of sexual violence, dating violence, domestic violence, and stalking. For the offenses of domestic violence, dating violence, and stalking, such statistics shall be compiled in accordance with the definitions used in section 4002(a) of the Violence Against Women Act of 1994. Since 2013, the United States Department of Education has refined reporting requirements and as such this document contains comprehensive supplements as provided by the Vice President for Human Resources, Planning, & Institutional Effectiveness; as well as the Dean of Student Affairs. They are listed as addendum A & B.

## *Definitions for Clery Offenses:*

**Murder and Non-Negligent Manslaughter:** The willful (non-negligent) killing of a human being by another.

**Manslaughter by Negligence:** The killing of another person through gross negligence.

**Rape:** The penetration, no matter how slight, of the vagina or anus with any body part or object, or oral penetration by a sex organ of another person, without the consent of the victim.

**Fondling:** The touching of the private body parts of another person for the purpose of sexual gratification, without the consent of the victim, including instances where the victim is incapable of giving consent because of his/her age or because of his/her temporary or permanent mental incapacity.

**Incest:** Sexual intercourse between persons who are, related to each other within the degrees wherein marriage is prohibited by law.

**Statutory Rape:** Sexual intercourse with a person who is under the statutory age of consent.

**Robbery:** The taking or attempting to take anything of value from the care, custody, or control of a person or persons by force or threat of force or violence and/or by putting the victim in fear.

**Aggravated Assault:** An unlawful attack by one person upon another, for the purpose of inflicting severe or aggravated bodily injury. This type of assault usually, is accompanied by the use of a weapon or by means likely to produce death or great bodily harm.

**Burglary:** The unlawful entry of a structure to commit a felony or a theft.

**Motor Vehicle Theft:** The theft or attempted theft of a motor vehicle.

**Arson:** Any willful or malicious burning or attempt to burn, with or without intent to defraud, a dwelling house, public building, motor vehicle or aircraft, personal property of another, etc.

**Dating Violence:** Violence committed by a person who (A) who is or has been in a social relationship of a romantic or intimate nature with the victim; and (B) where the existence of such a relationship shall be determined based on a consideration of the following factors: (i) the length of the relationship, (ii) the type of relationship, (iii) the frequency of interaction between the persons involved in the relationship. Dating violence includes, but is not limited to, sexual or physical abuse or the threat of sexual abuse.

**Domestic Violence:** Felony or misdemeanor crimes of violence committed by a current or former spouse of the victim or intimate partner of the victim, by a person with whom the victim shares a child in common, by a person who is cohabitating with or has cohabitated with the victim as a spouse, by a person similarly situated to a spouse of the victim under the domestic or family violence laws of the jurisdiction in which crime occurred or by any other person against an adult or youth victim who is protected from that person's acts under the domestic or family violence laws of the jurisdiction in which crime of violence occurred.

**Stalking:** Engaging in a course of conduct directed at a specific person that would cause a reasonable person to (A) fear for his or her safety or the safety of others; or (B) suffer substantial emotional distress.

**Weapons Violations (Carrying, Possessing, Etc.):** The violation of laws or ordinances prohibiting the manufacture, sale, purchase, transportation, possession, concealment, or use of firearms, cutting instruments, explosives, incendiary devices or other deadly weapons.

**Drug Abuse Violations:** The violation of laws prohibiting the production, distribution and/or use of certain controlled substances and the equipment or devices utilized in their preparation and/or use. The unlawful cultivation, manufacture, distribution, sale, purchase, use, possession, transportation or importation of any controlled drug or narcotic substance. Arrests for violations of state and local law, specifically those relating to the unlawful possession, sale, use, growing, manufacturing and making of narcotic drugs.

**Liquor Law Violations:** The violation of state or local laws or ordinances prohibiting the manufacture, sale, purchase, transportation, possession or use of alcoholic beverages, not including driving under the influence and drunkenness.

**Hate Crimes:** A criminal offense that manifests evidence that the victim was intentionally selected because of the perpetrator's bias against the victim. Although there are many possible categories of bias, under the Clery Act, only race, religion, sexual orientation, gender, gender identity, ethnicity, national origin and disability are reported.

**Larceny-Theft:** The unlawful taking, carrying, leading, or riding away of property from the possession or constructive possession of another. (Note: Constructive possession is defined by Black's Law Dictionary, 6th ed. as "where one does not have physical custody or possession, but is in a position to exercise dominion or control over a thing.")

**Simple Assault:** An unlawful physical attack by one person upon another where neither the offender displays a weapon, nor the victim suffers obvious severe or aggravated bodily injury involving apparent broken bones, loss of teeth, possible internal injury, severe laceration, or loss of consciousness.

**Intimidation:** To unlawfully place another person in reasonable fear of bodily harm through the use of threatening words and/or other conduct, but without displaying a weapon or subjecting the victim to actual physical attack.

**Destruction/Damage/Vandalism of Property:** To willfully or maliciously destroy, damage, deface, or otherwise injure real or personal property without the consent of the owner or the person having custody or control of it.

## *Related Definitions:*

**Advisor:** Any individual who provides the accuser or accused support, guidance, or advice.

**Awareness programs:** Community-wide or audience specific programming, initiatives, and strategies that increase audience knowledge and share information and resources to prevent violence, promote safety, and reduce perpetration.

**Bystander intervention:** Safe and positive options that may be carried out by an individual or individuals to prevent harm or intervene when there is a risk of dating violence, domestic violence, sexual assault, or stalking.

**Consent** (abbreviated): Clear unambiguous and voluntary agreement between the participating to engage in specific sexual activity.

**Ongoing prevention and awareness campaigns:** Programming, initiatives, and strategies that are sustained over time and focus on increasing understanding of topics relevant to and skills for addressing dating violence, domestic violence, sexual assault, and staking, using a range of strategies with audiences throughout the institution.

**Primary prevention programs:** Programming, initiatives, and strategies informed by research or assessed for value, effectiveness, or outcome that are intended to stop dating violence, domestic violence, sexual assault, and stalking before they occur through the promotion of positive and healthy behaviors that foster healthy, mutually respectful relationships, and sexuality, encourage safe bystander intervention, and seek to change behavior and social norms in healthy and safe direction.

**Proceeding:** All activities related to a non-criminal resolution of an institutional disciplinary complaint, including, but not limited to, fact finding investigations, formal or informal meetings, and hearings.

### **Programs to prevent dating violence, domestic violence, sexual assault, and stalking:**

Comprehensive, intentional, and integrated programming, initiatives, strategies, and campaigns intended to end dating violence, domestic violence, sexual assault, and stalking that:

- Are culturally relevant, inclusive of diverse communities and identities, sustainable, responsive to community needs, and informed by research or assessed for value, effectiveness, or outcome, and
- Consider environmental risk and protective factors as they occur on the individual, relationship, institutional, community and societal levels

**Prompt, fair, and impartial proceeding:** A proceeding that is completed within reasonably prompt timeframes designed by an institution's policy, including a process that allows for the extension of

timeframes for good cause and with written notice to the accuser and the accused of the delay and the reason for the delay.

**Result:** Any initial, interim, and final decision by any official or entity authorized to resolve disciplinary matters within the institution.

**Risk reduction:** Options designed to decrease perpetration and bystander inaction, and to increase empowerment for victims in order to promote safety and to help individuals and communities address conditions that facilitate violence.

**Sexual Assault (the victim, including instances where the victim is incapable of giving conSex Offenses):** Any sexual act directed against another person, without the consent of sent.

## *New Jersey Campus Sexual Assault Victim's Bill Of Rights*

*Adopted in 1995 by the New Jersey Commission on Higher Education, Pursuant to P.L. 1994 Chapter 160.*

A college or university in a free society must be devoted to the pursuit of truth and knowledge through reason and open communication among its members. Academic communities acknowledge the necessity of being intellectually stimulating where the diversity of ideas is valued. Its rules must be conceived for the purpose of furthering and protecting the rights of all members of the college community in achieving these ends.

The boundaries of personal freedom are limited by applicable state and federal laws and institutional rules and regulations governing interpersonal behavior. Respect for the individual and human dignity is of paramount importance in creating a community free from violence, sexual assault and non-consensual sexual contact.

The State of New Jersey recognizes that the impact of violence on its victims and the surrounding community can be severe and long lasting. Thus, it has established this Bill of Rights to articulate requirements for policies, procedures and services designed to insure that the needs of victims are met and that the colleges and universities in New Jersey create and maintain communities that support human dignity.

### **BILL OF RIGHTS NJSA18A:61E-1 et.seq.:**

**Campus Sexual Assault Victim's Bill of Rights:** A college in a free society must be devoted to the pursuit of truth and knowledge through reason and open communication among its members. Academic communities acknowledge the necessity of being intellectually stimulating where the diversity of ideas is valued. Its rules must be conceived for the purpose of furthering and protecting the rights of all members of the university community in achieving these ends. The boundaries of personal freedom are limited by applicable state and federal laws and institutional rules and regulations governing interpersonal behavior. In creating a community free from violence, sexual assault and non-consensual sexual contact, respect for the individual and human dignity are of paramount importance.

The State of New Jersey recognizes that the impact of violence on its victims and the surrounding community can be severe and long lasting. Thus, it has established this Bill of Rights to articulate requirements for policies, procedures and services designed to insure that the needs of victims are met and that the colleges and universities in New Jersey create and maintain communities that support human dignity.

The following Rights shall be accorded to victims of sexual assault that occur on the campus of any public or independent institution of higher education in the state of New Jersey and where the victim or alleged perpetrator is a student at that institution and/or when the victim is a student involved in an offcampus sexual assault.

### **1. Human Dignity Rights**

- To be free from any suggestion that victims must report the crimes. □ To be assured of any other right guaranteed under this policy.
- To have any allegations of sexual assault treated seriously; the right to be treated with dignity.
- To be free from any suggestion that victims are responsible for the commission of crimes against them.
- To be free from any pressure from campus personnel to report crimes if the victim does not wish to do so.
- Report crimes as lesser offenses than the victim perceives the crime to be.
- Refrain from reporting crimes to avoid unwanted personal publicity.

### **2. Rights to Resources On and Off Campus**

- To be notified of existing campus and community based medical, counseling, mental health and student services for victims of sexual assault whether or not the crime is formally reported to campus or civil authorities.
- To have access to campus counseling under the same terms and conditions as apply to other students in their institution seeking such counseling,
- To be informed of and assisted in exercising any rights to confidential or anonymous testing for sexually transmitted diseases, human immunodeficiency virus and/or pregnancy.
- Any rights that may be provided by law to compel and disclose the results of testing of sexual assault suspects for communicable diseases.

### **3. Campus Judicial Rights**

- To be afforded the same access to legal assistance as the accused.
- To be afforded the same opportunity to have others present during any campus disciplinary proceeding that is allowed the accused.
- To be notified of the outcome of the sexual assault disciplinary proceeding against the accused.

### **4. Legal Rights**

- To have any allegation of sexual assault investigated and adjudicated by the appropriate criminal and civil authorities of the jurisdiction in which the sexual assault is reported.
- To receive full and prompt cooperation and assistance of campus personnel in notifying the proper authorities.

- To full, prompt and victim-sensitive cooperation of campus personnel with regard to obtaining, securing and maintaining evidence, including a medical examination when it is necessary to preserve evidence of the assault.

#### 5. Campus Intervention Rights

- To require campus personnel to take reasonable and necessary actions to prevent further unwanted contact of victims by their alleged assailant,
- To be notified of the options for and provided assistance in changing academic and living situations if such changes are reasonably available.

### *Actions to be Taken Following a Sexual Assault:*

- **Step 1:** An individual who has been the victim of a crime, such as sexual assault or violence, is encouraged to get to a safe place and call 911 or Public Safety 973-684-5403 immediately. Even if the individual does not wish to report the criminal conduct to the College or to local law enforcement, he or she should still consider going to a hospital, both for his/her own health and well-being and so that evidence can be collected and preserved. Any evidence collected will be critically important should the individual decide to make an official report at a later time. The College wants complainants to pursue criminal action for incidents of sexual harassment, sexual violence and intimate partner violence that may also be crimes under New Jersey law. The College will also assist a complainant in making a criminal report and will cooperate with law enforcement agencies if a complainant decides to pursue the criminal process to the extent permitted by law.
- **Step 2:** All employee complaints of sexual misconduct must be brought to the immediate attention of the Title IX Coordinator, Mr. Jose A. Fernandez, Associate Vice President of Human Resources, 973-684-6108, [jfernandez@pccc.edu](mailto:jfernandez@pccc.edu). All student complaints of sexual misconduct must be brought to the immediate attention of the Deputy Title IX Coordinator, Dr. Sharon Goldstein, 973-684-6309, [sgoldstein@pccc.edu](mailto:sgoldstein@pccc.edu).
- **Step 3:** Should the Title IX Officer and Deputy Title IX Coordinator be unavailable, students and employees may report incidents of sexual misconduct to the Director of Security at 973684-5402.

## *Reporting Crimes and Emergencies*

**Passaic County Community College** maintains its own public safety department and provides protective services during the college's hours of operation. The community is encouraged to report all crimes whether actual, attempted, or suspected, as well as any other emergency situation, to the Public Safety Department or administrative office of any of our three satellite campuses (see telephone listing on prior page) as well as to the respective police department that is responsible for jurisdiction of the respective satellite campus. Students may also report crimes to Campus Security Authorities who are designated as the following: the Director of Athletics; the Dean of Students Affairs; the Director of Student Activities; the Director for the Center for Student Success; the Administrator of the Wayne Campus, the Administrator of the Passaic campus, and the Administrator of the Wanaque campus. While the Public Safety goal is to provide a safe environment for students, faculty, and staff, you are encouraged to be aware of your surroundings and take actions that will prevent incidents by partnering with Public Safety, such as reporting suspicious behavior. A comprehensive list of contact numbers precedes this page. Annually, the college's crime statistics are compiled from reports and investigations handled by the college's security department and/or police department. Passaic County Community College also includes the crime statistics obtained from the municipal police departments where our satellite campuses are located. It is important to know that a formal police or security report or investigation is not needed in order for a crime to be included in the crime statistics provided in this report. It is also noted that with your permission, the Director of Public Safety or designee can file a report on the details of an incident without revealing your identity. The purpose of a confidential report is to comply with your wish to keep the matter confidential, while taking steps to ensure the future safety of yourself and others.

## *Crime Prevention*

The Public Safety Departmental philosophy is to be proactive and prevent incidents from occurring to the extent possible. To that end, walking escorts are provided by public safety throughout the college's hours of operation. To request an escort contact public safety or the respective administrative office. Other crime prevention techniques include active campus patrols; use of technological systems such as closed circuit television cameras; electronic access control software with card readers located on outer campus doors and selected inner doors; and announcements to students, faculty, and staff on crime prevention tips and other safety tips.

## *Access to Campus Facilities*

Access to academic buildings, administrative offices, student services and recreational facilities by students, faculty, and staff is accomplished through the use of their assigned College ID badge which operates electronic card readers mounted on exterior building doors. Access policies inside academic buildings during hours when classes are not in session are established by the College Administration. The general public as well as vendors, contractors, and other businesspersons are required to check-in to the Public Safety Office (E-101) in Founders Hall at the Paterson campus; or to the administrative office at each satellite campus. Passaic County Community College does not have residence halls and its buildings are closed during the overnight hours.

## *Maintenance of Campus Facilities*

**Security and safety issues** are given high priority in the design of new facilities as well as existing facilities. The Public Safety Department, in an ongoing program, conducts security surveys of existing facilities, with findings and recommendations forwarded to appropriate administrative areas for remedial action when necessary. Surveys of campus lighting are conducted regularly and deficiencies promptly addressed.

## *Authority of Campus Public Safety, Public Safety Role, and Relationship with Local Law Enforcement Agencies*

**The Office of Campus Public Safety consists** of a Director, two supervisors, public safety officers, and operators/dispatchers who are non-sworn employees. Non-sworn employees do not possess law enforcement arrest authority. The role of Public Safety, including practices and procedures, as well other important information such as emergency response procedures; the Community Feedback form; and parking information, for example, can be found on the PCCC Public Safety web site.

Passaic County Community College has a strong working relationship between the PCCC Public Safety Department and the Passaic County Sheriff's Department and municipal law enforcement. The Passaic County Sheriff's Department has primary responsibility of response, investigation, arrest and subsequent prosecution of any criminal activities. The College occupies several off-campus properties, located in the City of Passaic, Township of Wayne and the Borough of Wanaque. The Paterson, Passaic, Wayne and Wanaque Police Departments maintains a close relationship, monitors and responds to emergencies and criminal activity at these locations, and shares all pertinent information with Campus Public Safety Officials when appropriate. The Passaic County Prosecutor's Office also serves as a valuable resource to the Office of Campus Public Safety. Other law enforcement agencies, such as the State Police or FBI will be contacted as appropriate to the situation.

## *Registered Sex Offenders*

New Jersey law authorizes the Division of State Police to make available to the public over the internet information about certain sex offenders required to under Megan's Law. The sex offender internet registry law can be found in the criminal justice code of the New Jersey statutes at 2C:7-12 to 129. ## *Daily Crime Log*

The Department of Public Safety maintains a written Daily Crime Log as required by the Campus Security Act. The Daily Crime Log records the date that the crime was reported; any Clery related crime that occurred on campuses or in public areas immediately adjacent to or running through campuses; and in certain non-campus facilities as defined by the Clery Act. The log includes the nature, date, time, and general location of each crime reported to the Department as well as the disposition of the complaint, if known at the time the log is written. The log is located in the Public Safety Office of Founders Hall, E100, and may be viewed upon request.

## *Timely Warnings*

In the event a situation arises, either on campus or adjacent to a campus, that, in the judgment of College Officials, constitutes an ongoing or continuing threat, a campus wide "timely warning" will be issued. The warning will be issued through the college e-mail system and / or the emergency alert system as deemed best and appropriate.

## *Possession of Alcoholic Beverages & Illegal Possession of Drugs*

Passaic County Community College has been designated as "Drug Free." The possession, sale, or furnishing of alcohol on any campus is prohibited. Likewise, the possession, sale, manufacture or distribution of any controlled substance is illegal under state and federal laws. Such laws are strictly enforced by the Public Safety Department. Violators are subject to disciplinary action, criminal prosecution, fine and imprisonment. It is a violation of College policy to possess alcohol in any public or private area of campus without prior approval, which includes organizations or groups.

# *Sexual Assault Prevention, Reporting of Offenses, Counseling, & Disciplinary Action*

Prevention of sexual assault is accomplished through a number of methods, to include active patrols by Public Safety Officers of all areas of the campus and campus buildings including remote areas; educational programs to promote awareness of sexual assault prevention via College counselors, and the securing of all campus buildings during the overnight hours. The Human Resources Department has taken steps to provide notifications to the College Community regarding actions to be taken in the event of an incident of sexual misconduct, and this was done via e-mail communication as well as posting information in the Human Resources section of the Passaic County community college web site. PCCC has no residence halls. Should a sexual assault of a student or employee occur victim(s) are encouraged to report the incident to the Police and/or any of the following officials at the College: Title IX Officer (973-684-6919); Alternate Title IX Officer (973-684-6274); Dean of Student Affairs (973-684-6919) for student incidents; or the Director of Public Safety (973-684-5402) for student or employee incidents. It is important for the victim to preserve evidence that may assist in proving that the alleged criminal offense occurred or that may be helpful in obtaining a protection order. The College is committed to supporting the victim's exercise of informed choice among services offered, and will work with the student to preserve evidence as well as assisting the student in notifying law enforcement authorities, if the student so requests. The College will assist the complainant in accessing other available complainant advocacy, academic support, counseling referrals, disability, health or mental health services, and legal assistance both on and off campus; provide other security and support, which could include issuing a no-contact or restraining order, helping arrange a change of working arrangements or course schedule (including for the alleged perpetrator pending the outcome of an investigation) or adjustments for assignments or tests; and inform the complainant of the right to report a crime to campus or local law enforcement – and provide the complainant with assistance if the complainant wishes to do so. Throughout the investigative and disciplinary process, the accuser and the accused are entitled to the same opportunities to have a support person present throughout the proceedings and will be informed of the outcome of any institutional disciplinary proceeding that is brought alleging sexual misconduct.
